

**La Valle Town Board Meeting
Monday September 13, 2021
MINUTES**

1. Chairman Demaskie called the September 13, 2021 Town Board Meeting to order 7:00pm. Roll Call: Mercier-present; Geils-present; Rego-present; Geitz-present; Demaskie-present. All members present.
2. The Pledge of Allegiance was recited.
3. Motion by Mercier second by Geils: To adopt the posted agenda for September 13, 2021. Voice vote- all aye. Motion carried.
4. Motion by Rego second by Geitz: To approve the August 9, 2021 Town Board Meeting Minutes and August 30, 2021 Special Town Board Meeting Minutes. Voice vote- all aye. Motion carried.
5. Financial report presented by Treasurer Geitz.
 - 5a. Motion by Geitz second by Geils: To approve payment of vouchers number 23206 thru 23257 for \$83,230.97. Voice vote-all aye. Motion carried. Motion by Geitz second by Rego: To approve possible payment of \$300.00 to Daniel Cofer for a violation that disturbed the ditch on 0.10 acres of field no. 13 CP21, that was in the program CREP (Conservation Reserved Enhancement Program). 8. Police and Boat Patrol Report presented by Officer Astle, previous months reports and other related activities and updates to the Town Board.
9. Public Works Report presented by Public Works Director Alan Johnson, road reports and other related activities and updates to the Town Board. Johnson recommended the town board to approve to open the recycling site on Wednesday December 29, 2021 due to Christmas Day and New Year's Day will fall on a Saturday and the site if closed on Holiday's. Motion by Rego second by Geils: To Open the Recycling Site on Wednesday December 29, 2021 from 1:00pm to 4:00pm. and to hang signs to let the public know of this one time date change. Motion by Mercier second by Geils: To approve and allow the Public Works Department to trim the brush and cut the low hanging tree limbs on Bundy Hollow Road, due to the complaints from the Bus Garage Superintendent, Mail carrier, White Farms the limbs are too low and are hitting the tops of the vehicles. Roll Call Vote: Mercier-aye; Geils-aye; Rego-aye; Geitz-aye; Demaskie-aye. Roll call vote, all aye. Motion carried.

11. The board briefly discussed the Fire alarm inspection quote more information is needed and to discuss further at a future town board meeting.
12. Fire Department Report updates presented by Supervisor Mercier. Lucas Milewski wrote and applied for a Grant on behave of the Fire Department and the Grant was accepted for the amount of \$231,000.00 to purchase outdated radio radios and equipment. Township portion to pay (96%) will be \$10,000.00 and the Village 4%. There were 23 calls of service,15 to the township, 116 calls all year.
